

SUPPLEMENTAL INFORMATION

The Supplementary Information (SI) appendix is limited to data and other materials that are important to the understanding and interpretation of the main paper that directly support the main conclusions of the published paper, but cannot be included in the main paper for reasons such as space or file format restrictions. The amount of SI material should be limited and justified.

SI should not repeat material in the main paper, and should be original and not previously published. SI should be within the conceptual scope of the main paper and not extend beyond it. SI cannot present data that is preliminary and not already discussed in the main paper.

SI can include additional control data, large datasets, non-printable media files, primary data, and/or validation of methods and reagents. SI can also include information about materials and/or specific experimental procedures, e.g. chemical synthesis, code, or computational modeling.

SI material will still undergo editorial and peer review, but will not be edited or formatted. SI would be made available online as additional information provided by the authors, who would be solely responsible for the accuracy and presentation of all SI material. JEAMS is not responsible for any errors contained in the SI.

FIGURES AND TABLES

SI items should refer to specific item(s) in the main paper to which they are most directly related. SI items should not be related to multiple sections of the main paper. Authors are permitted to submit more than one SI figure that is related to the main paper's figure or table (or vice versa).

All SI items must be cited at least once in the text of the main paper, e.g. "See also Figure S1." This relationship can be stated in the SI item's title, e.g. Figure S1. Related to Figure 2 and Table 3.

Figures should be labeled Figure S1, Figure S2, Figure S3, etc., and each figure should include a title and a legend. Each figure should fit onto its own single 8.5" x 11" page.

Tables should be labeled Table S1, Table S2, Table S3, etc., and each table should include a title and footnotes, if appropriate. A title is required, a legend is optional.

AUDIO AND VIDEO

An audio file in MP3 file format and/or a high resolution video file for the JEAMS website can be submitted in AVI, MPEG, or QuickTime file formats. Readers must not be required to download particular codecs. The video file must be playable on computers with standard media players, such as QuickTime or Windows Media Player. A title is required, a legend is optional.

TRIAL PROTOCOL AND STATISTICAL ANALYSIS PLAN

If a clinical trial is involved, then the protocol should be described.

Authors should describe statistical methods with enough detail to enable a knowledgeable reader with access to the original data to verify the results. A detailed description of the statistical tests used during the analysis in the methods must be included in a separate page entitled, "Statistical Analysis."

FORMATTING AND SIZE

SI must be submitted both as a PDF and as a Word file that are paginated, where the page breaks are inserted. The final size of this PDF should be less than 10 MB in order to permit successful downloads for the readers.

If a table cannot fit onto the 8.5" x 11" page of the PDF, the author can submit the table as an Excel or CSV file. Each table should be submitted as separate Excel files, not combined into one Excel file.

SI cannot contain its own Results or Discussion section. The citations and corresponding list of references should be self-contained within the pages of the SI.
